# Hong Kong Schools Mooting and Mock Trial Association 3<sup>rd</sup> Hong Kong Inter School Mock Trial Challenge RULES AND REGULATIONS

#### I. GENERAL

- 1. The Hong Kong Inter School Mock Trial Challenge ("the Challenge") shall be run by the Hong Kong Schools Mooting and Mock Trial Association ("Association"), which the Association collectively shall have the power to:-
  - 1.1. Administer the Competition; and
  - 1.2. Amend these rules as it thinks fit.
- 2. There shall be TWELVE (12) teams. Participants can come from the same school and compete on behalf of their school, or from different schools and compete as a team. There shall be no more than FOUR (4) participants per team.
- 3. The Association will determine the mock trial problems to be used in the Competition. Any ambiguities or objections apparently arising out of the mock trial problem shall be brought to the attention of the Association within two (2) days of receipt of the problem by the participants. The Association shall have the power to resolve the matter in her absolute discretion.

### II. PARTICULARS OF THE CHALLENGE

- 4. The Challenge shall comprise of FOUR (4) rounds. The Challenge will be held in the form of mock trial. The FOUR (4) teams would highest marks would compete in the Finals.
- 5. All competitors shall prepare for **both** the Prosecution and the Defence.
- 6. All competitors should dress in proper attire and shall observe court etiquette strictly. No competitors should wear a school uniform or anyways that the identity of their school can be identified.
- 7. All schools/teams will be assigned with a team name. Under no circumstances should the teams reveal the identity of their school to the judges.

- 8. The Challenge shall be conducted according to the following rules:
  - 8.1. A magistracy mock trial problem shall be assigned and the Challenge shall be presided by a single judge sitting with (or without) silent juror(s). The Association has absolute discretion to appoint any person she deems appropriate to be the presiding magistrate and/or silent juror.
  - 8.2. The Defence is not allowed to plead guilty and/or request for a *voir dire*.
  - 8.3. The Prosecution Counsel will first open his case. No opening submissions are required and/or allowed. Prosecution is <u>not</u> required to read out the admitted facts.
  - 8.4. Prosecution shall call the witness in which the Prosecution Counsel will conduct examination-in-chief, followed by cross examination by the Defence Counsel and re-examination, if any, by the Prosecution Counsel.
  - 8.5. After the Prosecution case, the Defence counsel will open his case in the same manner. NO opening submissions are required and/or allowed.
  - 8.6. NO interim submissions are required and/or allowed.
  - 8.7. After the Defence case, the Prosecution and the Defence will deliver their closing submission respectively.
  - 8.8. Each side will be given a total of **20 minutes** to conduct their trial. Time for handling judicial intervention is **included**.
  - 8.9. Time shall be kept on a stopwatch by a representative sent by the competing teams respectively. An A4 card should be held up when he/she has:-
    - 8.9.1. 10 minutes left
    - 8.9.2. 5 minutes left
    - 8.9.3. 1 minute left
    - 8.9.4. to conclude their speech forthwith

9. Witness should be tendered in the following sequence:

PW: PC 2321 Shiu Sum Mong Defendant: Ying Chor Yun

Each team shall produce a student to serve as witnesses.

10. Parties are ONLY allowed to rely on authorities provided in the "Authorities Bundle". No one may submit extra authorities from Hong Kong, English, or any other common law and/or civil law jurisdictions.

11. The law of evidence and criminal procedure of the Hong Kong Special Administrative Region applies in the trial.

### III. PAIRING AND AWARDS

- 12. In each courtroom, FOUR (4) teams (1, 2, 3, 4) shall compete in front of the same combination of judges.
  - 12.1. In each courtroom, two teams shall be allocated as the Prosecution (e.g. Team 1 and Team 3) and the Defence (e.g. Team 2 and Team 4) respectively.
  - 12.2. In Round (A), Team 1 shall play as **counsel** for the Prosecution and Team 2 shall play as **counsel** for the Defence. One student for Team 3 shall act as the prosecution witness and one student for Team 4 shall act as the defendant.
  - 12.3. In Round (B), Team 3 shall play as **counsel** for the Prosecution and Team 4 shall play as **counsel** for the Defence. One student for Team 1 shall act as the prosecution witness and one student for Team 2 shall act as the defendant.
- 13. Based on the performance of competitors, the following awards shall be given out:-
  - 13.1. Overall Champion;
  - 13.2. Overall 1st Runner-up;
  - 13.3. Overall 2<sup>nd</sup> Runner-up;

- 13.4. THREE (3) Best Advocate(s);
- 13.5. THREE (3) Outstanding Advocate(s);
- 13.6. THREE (3) Best Witness(s); and
- 13.7. THREE (3) Outstanding Witness(s).

- 7. Cross-Examination by Prosecution Counsel B
- 8. Re-Examination by Defence Counsel B (Optional)
