# Hong Kong Schools Mooting and Mock Trial Competition 2022/23 (the "Competition") 2022/23 香港學界模擬辯護及模擬法庭比賽 (「比賽」)

#### 賽制

比賽分中文及英文組,每組名額各二十四隊。

比賽賽事分為「初賽」(兩輪)、「半準決賽」、「準決賽」及「總決賽」五輪。「初賽」及「總決賽」將以<u>原審方式</u>作賽, 「半準決賽」及「準決賽」將以上訴方式作賽。

初賽: 各隊不論輸贏均需進行兩輪「初賽」。「第一回

合初賽」及「第二回合初賽」的題目分別為裁判

法院及區域法院的刑事審訊。

半準決賽: 雙方就一宗高等法院上訴法庭的案件,在三名法

官席前以上訴形式作賽。

準決賽: 雙方就一宗終審法院的案件,在五名法官席前以

上訴形式作賽。

總決賽: 雙方就一宗高等法院原訟法庭刑事案件在一名法

官會同陪審團席前作賽。

#### 法律導師

每參賽隊伍均會由至少一名本地法律大學生擔任法律導師指導 參賽學生及與學生交流。

## 「模擬法庭」與「模擬辯護」

「模擬法庭」是以「原審」方式作賽,對賽雙方分別擔任控方 或辯方,輪流作開案及結案陳詞、傳召證人及盤問對方證人。

「**模擬辯護**」是以「上訴」方式作賽,雙方分配擔任案件的上 訴方或答辩方,輪流向法官陳詞。比賽前雙方須要交換陳詞大 網及案例宗卷供法官及對方參閱。

#### **Competition Structure**

The Competition comprises a Chinese and an English division, each holding 24 teams.

5 rounds of Competition will be held, which consist of the "Preliminaries" (2 rounds), "Quarter Finals", "Semi Finals", and "Grand Finals". The "Preliminaries" and the "Grand Finals" will be held in form of a <u>mock trial</u>. The "Quarter Finals" and the "Semi Finals" will be held in the form of a <u>moot appeal</u>.

<u>Preliminaries</u>: <u>All participants (regardless of results)</u> will

compete in Preliminaries I <u>AND</u> II. Preliminaries I and II shall be Magistracy and District Court

criminal trials respectively.

Quarter Finals: Participants will moot on an appeal set scene in

the Court of Appeal before a 3-judge bench.

Semi Finals: Participants will moot on a case set scene in the

Court of Final Appeal before a 5-judge bench.

<u>Grand Finals</u>: Participants will compete in a jury mock trial

problem set scene in the Court of First Instance

before a judge sitting with a jury.

#### **Law Tutor**

Each team is allocated with (a) law student(s) reading law in local universities to guide and interact with students.

#### **Mock Trial vs Moot**

In **Mock Trials**, teams will act for the Prosecution or the Defence respectively where they would make opening and closing submissions, and lead evidence from witnesses.

In **Moots**, teams will act for the Appellant or the Respondent where they would make submissions before a bench. Participants will be required to submit and exchange their <u>Skeleton Arguments</u> and <u>Bundle of Authorities</u> prior to the moot.

#### **Registration Fees**

- HK\$ 3,000 per team
- HK\$ 2,700 per team for entering
  - (i) into BOTH DIVISIONS;
  - (ii) MORE THAN ONE team in either division; or
  - (iii) within the Early Bird Period.
